

Made In Montana or Grown In Montana Logo on Disk

The "Made In Montana" and "Grown In Montana" logos are registered trademarks of the Montana Department of Commerce. Color World Printers serves as the sole contractor for the sales and distribution of promotional materials.

By signing this order form you are agreeing to abide by the following:

1. The business or individual must produce a qualifying value-added product.

The definition of a qualifying value-added product means: a finished product that has been created, made, produced, or enhanced, by a Montana resident, within the state of Montana, resulting in 50% or more added value.

Note: The Montana Department of Commerce encourages businesses and individuals to obtain raw materials in state; which in turn, helps to support their local economies and other Montana businesses. Commerce staff will assist businesses or individuals in locating in-state suppliers and resources upon request. Montana resident artists, authors, and performing artists qualify to use the logos.

2. The logos can only be placed on qualified value-added products, printed material directly attached to the products, or in promotional materials advertising the qualified products i.e., display racks, product brochures & websites.
3. The logos cannot be used on any general company literature such as business cards, letterhead, annual reports, etc. Unauthorized use will result in the termination of the right to use the logos.
4. The logo cannot be used for signage purposes without authorization from the Montana Department of Commerce.
5. The logo fonts, design, layout or 4-color scheme cannot be altered in any way. Ordering a 1-color, monochrome logo can be specified below.
6. Failure to remit the annual fee, when invoiced, will result in the termination of the right to use the logos.

The logo is available on 3.5" IBM or Macintosh floppy disk (Adobe Illustrator .eps format) or can be transmitted via email.

An **annual fee**, based on the businesses or individual's yearly sales, is required for use of the logo. Annual invoices will be sent as fees become due. Annual fees guidelines are as follows:

Less than \$500,000	\$ 75.00	\$500,000 to \$1 Million	\$200.00
\$1 Million to \$5 Million	\$300.00	More than \$5 Million	\$500.00
